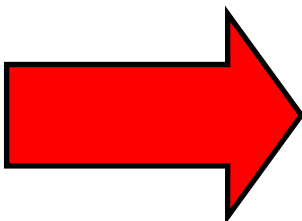

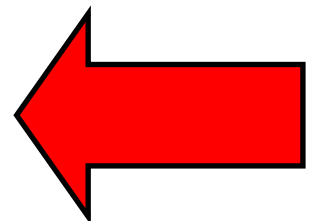

Section 13-2-1. Running at Large Prohibited. No owner of **any animal** shall permit it to run **at large** within the Flandreau Santee Sioux Reservation **at any time**. Any animal found at large may be impounded by the Animal Control Officer or Law Enforcement, and the owner may be subject to a fine as set by the court. (Passed by Resolution number 19-20 on March 7, 2019.)

Section 13-1-2. Definitions. For the purposes of this Title, the following definitions shall apply:

AT LARGE – An animal shall be deemed to be running at large when off or away from the owner's premises and not under control of the owner, possessor, keeper, agent, servant, or a member of his immediate family.

Toby Nicholas Taylor

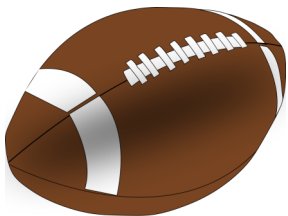
August 09, 2002 - March 27, 2019

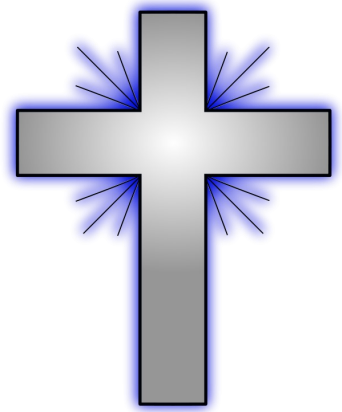

Think of the things that are important to you. Use meth and chances are, they'll all be gone. That's because using meth just once can lead to addiction. And it's an addiction that will completely take over your life. You'll lie. You'll cheat. You'll steal. You'll become someone you're not. Do yourself a favor and stay away from it.

Knowing the signs of meth abuse might help you save someone's life.

Certain behavioral and physical changes are common among meth users. Signs of meth abuse include:

- Hyperactivity
- Drastic weight loss
- Dilated pupils
- Talkativeness
- Increased distractibility
- Tooth decay and loss of teeth
- Aggression
- Irritability
- Agitation
- Grandiose behavior
- Twitchiness
- Loss of interest in normal activities, such as food, water, sex, and sleep
- Getting "sketched out," or becoming agitated, nervous, moody, irritable, paranoid, and/or aggressive.
- Jumpy eyes
- Scratching, itching, or picking at skin
- Financial difficulties
- Not meeting financial obligations
- Absenteeism or tardiness at school or work
- Noticeable changes in behavior
- Cravings
- Social and interpersonal problems
- Impulsive behaviors
- Memory loss
- Bizarre and erratic behavior
- Repetitive behavior patterns that can last for hours, also called "tweaking" or "geeking."

Nebraska. Numerous levee breaches have already occurred on the Missouri River to include; RM 597 (north of Plattsmouth, Nebraska); RM 543 (west of Hamburg, Iowa); RM 538 (three miles upstream of Brownville) and RM 553 as well as Union Dike near Valley, Nebraska. Additional breaches are expected over the next 24 hours as a result of the extremely high flows. Peak flows are not expected to be seen for another 24 to 48 hours in the Omaha area.

USACE dams along Papillion Creek in Omaha, and Salt Creek in Lincoln are also being inspected and are currently operating well reducing the impact on the Platte River.

"The devastating overflow of the levees that we are experiencing on the Missouri River and many of its larger tributaries is the result of the widespread rain and snowmelt earlier this week. The weather event resulted in record runoff from unregulated tributaries below Ft. Randall Dam and into the Missouri River system. I encourage residents to continue to monitor the very serious situation and keep in close contact with their local and state emergency management organizations to stay updated on any evacuation plans and emergency conditions," urged Col. John Hudson, USACE-Omaha District Commander.

USACE terminated all releases from Fort Randall Dam ahead of the storm reduce the impact of unregulated runoff into Gavin's Point Dam and downstream. That action enabled the Army Corps to capture a small component of the peak unregulated runoff in the Gavins Point Reservoir.

Although these efforts have limited impact on the overall magnitude of this unregulated flooding event downstream of Gavins Point Dam, they reduced some of the peak flows that would

have occurred in the absence of the dam.

Releases from Gavins Point Dam were reduced to 73,000 cubic feet per second (cfs) Saturday morning, and are planned to be gradually reduced over the coming days reaching 20,000 cfs by Tuesday, March 19.

USACE continues to coordinate with its many stakeholders to include the Nebraska, Iowa and South

Dakota Emergency Management Agencies, as well as local emergency management officials through the affected states.

Additionally, the Corps has open lines of communication with local and tribal governments in their flood fight efforts.

To date, the Omaha District has distributed approximately 135,000 sandbags, 1920 super sandbags, 2700 feet of HESCO Barriers, one 16" water pump, 18

poly rolls, four 16" hoses and eight 10" heavy duty T-Bolt Clamps to mitigate flood conditions.

Noem vetoes Industrial Hemp legislation

Pierre, SD – March 11, 2019 – Governor Kristi Noem today vetoed HB1191 and sent the following message to the South Dakota House of Representatives:

Dear Mr. Speaker and Members of the House of Representatives.

I respectfully return to you House Bill 1191, with my VETO. House Bill 1191 is an Act to legalize the growth, production, and processing of industrial hemp and derivative products in the state.

South Dakota must stand as an example for the rest of the country, not simply go along with others. Our focus must be on leading for South Dakota's next generation. Our state is not yet ready for industrial hemp.

Foremost among the many defects of this bill are the challenges it creates for law enforcement. HB 1191 complicates law enforcement searches and provides a ready-made defense for those breaking our drug laws. This poorly drafted bill changes the definition of marijuana with little regard for the implications elsewhere in our Code. It would create uncertainty for prosecution under our ingestion statute because the source of THC is placed in doubt when industrial hemp products that contain small amounts of THC, such as cannabidiol or CBD, are legalized.

As Governor, I will not leave it to our courts to interpret how this bill impacts our prohibition on the active ingredient in marijuana, and I do not believe the Legislature intended to complicate enforcement of our ingestion statute in this way.

Although proponents claim hemp has a wide variety of uses, the legislative debate makes it clear that this bill is less about helping farmers and more about commercial interest in one product: CBD. No other type of hemp producer or processor retained paid lobbyists this Session. HB 1191 rejected critical parts of the amendment my Administration discussed with the bill's sponsors. It would instead allow the immediate, widespread production and use of CBD, as well as other hemp derivatives, even though the Food and Drug Administration ("FDA") has yet to approve them as safe for therapeutic use or for interstate commerce. In fact, the FDA has not yet begun its regulatory process on hemp derivatives, including CBD. South Dakota should be guided by the FDA on these issues, not special interests.

As I first stated many weeks ago, HB 1191 is premature. There is no urgent problem requiring an immediate solution this session. Until the U.S. Department of Agriculture ("USDA") issues its own rules, the regular growth and

interstate transport of hemp cannot begin. No industrial hemp will cross into South Dakota without those rules, which USDA has announced it will not issue until late 2019.

We have no way of knowing today what those rules will require. What limited structure HB 1191 does create to regulate industrial hemp in our state could very well be in conflict.

Finally, I am concerned that this bill supports a national effort to legalize marijuana for recreational use. I do not doubt the motives of this bill's legislative champions. However, an overwhelming number of contacts I have received in favor of this bill come from pro-marijuana activists. There is no question in my mind that normalizing hemp, like legalizing medical marijuana, is part of a larger strategy to undermine enforcement of the drug laws and make legalized marijuana inevitable.

This issue was never ripe for discussion during this legislative session, and our state government's efforts and resources should be focused elsewhere until the federal government's approach on this issue is clear.

For these reasons, I oppose this bill and ask that you sustain my veto.

Statement by Hemp Bill sponsor after veto upheld

After Keystone XL bill package, SD tribes pull out of flag ceremony

Rapid City Journal – March 15, 2019 – A week after the Legislature pushed through Gov. Kristi Noem's Keystone XL pipeline bill package, four of South Dakota's tribal chairmen are rescinding their tribes from a ceremony to be held in Pierre.

Chairmen of the Oglala Sioux and Crow Creek Sioux tribes released statements on Monday, requesting that their tribes not be included in the ceremony at the state Capitol, where Noem's administration plans to erect the flags of South Dakota's nine

federally recognized tribes "as a sign of unity."

Lower Brule and the Yankton Sioux tribes soon issued their own similar such statements.

On Feb. 27, State-Tribal Relations Day, Noem announced her intentions to hold the ceremony. Less than one week later, Noem unveiled her Keystone XL bill package.

"The purpose of these bills is to punish anyone who opposes the agenda of outside oil conglomerates like TransCanada," Oglala Sioux President Julian Bear Runner said in Monday's release. "Their effects will be to violate the constitutional rights

of South Dakotans and Americans as well as the treaty rights of the Oglala nationals."

Senate Bill 189 establishes civil penalties for "riot boosting," or contributing money to or encouraging violent pipeline protesters. Senate Bill 190 creates a funding source for extraordinary costs attributed to pipeline protests, sourced from local, state and federal

dollars, as well as contributions from the pipeline company.

Noem said she consulted lawmakers, law enforcement and TransCanada in her development of Senate bills 189 and 190. Tribal leaders said they were not consulted.

"I'm well aware that some of our (tribal) leaders are not in favor of the pipeline, although we should all be in favor of it being peaceful," Noem said when she introduced the package.

In a March 6 joint hearing on the bill package, Matt McCauley, who serves as legal counsel to Noem's office, said tribes weren't consulted because the proposed pipeline route does not intersect with tribal land. The Legislature then suspended legislative rules in order to pass both bills by the deadline.

Crow Creek Sioux Tribal Chairman Lester Thompson said in Monday's release that Noem "deliberately omitted tribal nations from any consultation or discussions."

Thompson said he had "high expectations" for Noem to build state-tribal relations, but "the actions of Gov. Noem and the state Legislature have destroyed our trust and the hopeful advancement toward reconciliation."

The Oglala, Crow Creek and Yankton Sioux tribes asked that their flags not be shown in the Capitol display.

"I am respectfully requesting that our flag be removed so we do not have to come and remove it ourselves," Bear Runner said. "Our flag represents a commitment to protect Mother Earth, to respect the interdependent relationship we have with what westerners call 'natural resources.'"

He continued, "Until our free, prior and informed consent is obtained with respect to the Keystone XL pipeline, we will not allow our flag to fly in the governor's rotunda."

Lower Brule's statement did not specifically ask for its flag's removal, though chairman Boyd Gourneau sharply criticized SB189 and 190, and the governor's lack of consultation with tribal leaders.

"We realize that our State's nine Tribes do not own all of the land we have originally inhabited within our great State," Gourneau wrote. "However as the original stewards of this very land, it is natural that we expect some regard and consultation during the

preparation of legislation that would surely affect the wellbeing of our environment."
