

Flourless Chocolate Cake

Ingredients:

4 Eggs

8 oz of Ghirardelli Chocolate Chips

1/4 Cup of Butter

Powdered Sugar for Dusting



Method:

Preheat oven to 325 F. Grease and line an 8" round cake pan with parchment paper. In a mixer, whip eggs on high speed until double in size. Approximately 5 minutes.

In a medium bowl set over a double boiler, melt the chocolate and butter stirring occasionally until smooth.

Fold 1/3 of the egg mix into the chocolate until a few streaks remain. Fold remaining egg mixer into the chocolate in two separate additions.

Pour Batter into prepared pans. Bake in a hot water bath, until edges are slightly risen, the cake is set and the center temperature of the cake is 140 degrees F. Cool and refrigerate over night.

Garnish with powdered sugar, berries and sauce.



January 22, 2025 – Wakpa Ipaksan

We are happy to inform you that we have received a grant from the U.S. Environmental Protection Agency in the amount of \$19,949,725.00. This grant is awarded to the Flandreau Santee Sioux Tribe from the Community Change Grant and has been earmarked for the completion of several community projects.

The most anticipated is the completion of the Crescent Street Bridge. FSST Environmental Advancement Project will serve the Flandreau Santee Sioux Tribe (FSST) in Flandreau, South Dakota. It will create a zero-emission transportation corridor to replace the Crescent Street Bridge damaged in 2022. Preliminary plans include a spot for fishing off the west side of the bridge, a two-lane road, and a biking and walking path on the east side.

This corridor will provide clean transportation options and other infrastructure improvements, including ADA-accessible mobility options. A bike path, with electric bikes available to rent, is planned to begin near our headquarters, crossing through the city, across the new bridge, north to FIS and out to highway 13, turning north to the Wacipi Grounds. Collaboration with the City is ongoing to integrate our new bike path with one currently being planned by the city.

Additionally, the Flandreau Santee Sioux Tribe will partner with the Native Sun Community Power Development to support investments in green infrastructure, including roof retrofits and upgrades, new solar capacity, building weatherization, and the construction of multiple resilience hubs to support tribal operations in cases of emergency.



January 15, 2025 – Flandreau, SD

Last year a vote was taken to ban South Dakota's Governor Kristi Noem from our territories at the request of our people. We met face to face with the governor and discussed not only the issues at hand but focused on how we can work together to resolve issues of mutual concern.

The Governor issued an apology to us for the misunderstanding, which was exacerbated by misinformation. Over the past several months, we have been made aware of many circumstances relating to the comments made by the Governor; only to find out that these issues are real and pose a grave threat to the stability of our Nations and the health and well-being of all our people.

Since our first meeting, the Governor has shown us that she is committed to protecting the people of South Dakota including the citizens of the nine Tribal Nations, who share mutual borders with the state. Our partnership with the City of Flandreau and the Boys & Girls Club of the Northern Plains are grateful for her support in the development of the Early Childhood Learning Center. The Governor's commitment to have a cooperative working relationship between all levels of Law Enforcement is evident in her efforts to bring a 13-week Police Officer Training Program to the state, which has successfully graduated nine Native American Law Enforcement Officers. It is for these reasons that we hereby dissolve the order of banishment.

Lastly, we wholeheartedly welcome her nomination and eventual appointment as the Secretary for Homeland Security and wish her much success in her future endeavors.

Executive Grant of Clemency

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

I HEREBY COMMUTE the remainder of the total sentence of imprisonment imposed upon **LEONARD PELTIER**, Reg. No. **89637-132**, to be served in its entirety on home confinement, to take effect on **February 18, 2025**. I leave intact all other components of the sentence.

I HEREBY DESIGNATE, direct, and empower the Pardon Attorney, as my representative, to deliver to the Bureau of Prisons a certified copy of the signed warrant as evidence of my action in order to carry into effect the terms of these grants of clemency, and to deliver a certified copy of the signed warrant to each person to whom I have granted clemency as evidence of my action.



The **FSST Solar Energy Department** is proud to announce the launch of the Solar For All Project, a collaborative partnership between the EPA and Indigenized Energy. Funded through a \$135 million EPA grant shared among 14 tribes across the Great Plains, this groundbreaking initiative will provide PV (Photovoltaic) solar array systems to eligible tribal members in Moody County. The project aims to reduce energy costs, enhance sustainability, and foster a cleaner, greener future. Applications are now open to be part of this monumental effort!

- Rent home from the Tribe


System Allocation:




Our Nation has an opportunity to purchase the Sonesta Maho Beach Resort, Casino & Spa located on the Island of St. Maarten which is a part of an archipelago owned by the Netherlands. The island is shared with the country of France and is divided by a political boundary that residents and guest can freely pass and visit.

Friendship Treaty

The Friendship Treaty with Sint Maarten and the Netherlands, which is also called the Dutch-American Friendship Treaty or DAFT, allows U.S. Citizens to easily obtain residency in St. Maarten without needing a separate work permit, essentially giving them the same rights as Dutch Nationals living on the island. This being a bi-lateral agreement between the United States and the Netherlands. Under this treaty our membership can live, work and retire in St. Maarten with or without this purchase.





All Inclusive Resort

The 420 Room Resort is located minutes from the airport overlooking the Maho Bay. Planes fly directly overhead while on-lookers and beach goers capture some amazing photos of planes landing just yards from the beach.

One of the many attractive features of the resort is it being an all inclusive vacation. This feature allows guests access to a wide variety of amenities located across the 10 acre resort. The wrist band not only gives you access to your room but to all the dining establishments throughout the resort; including the Lounges, Bars and Swim Up Bars. All the food, sun and drinks you can possibly enjoy.

Guests of the 9th and 10th floor have exclusive access to the roof top lounges as well as a 24 Hour Snack Bar filled with sandwiches, pastries, sweets, fruits and beverages.






Adult Only Resort

The Azul Restaurant located on the point of the resort, hangs over the cliff and offers guests magnificent views of the bay while they dine.

Guests must have a special wrist band to access this part of the resort. The hotel rooms are enormous and come with their own kitchen.




Rooms on the bottom level enjoy their own lazy river, where they can rest and swim under tropical foliage. A lazy river surrounds the bottom level of the hotel and flows into a man made lagoon, where beach goers can bare it all if they choose.

A convention center is located in the Adult Only Resort Hotel where meetings, conventions and special occasions take place. A newly remodeled work out facility has just been completed and is shared by all guests.



MEMBER BENEFITS

If this purchase is made a reality, it is the vision of the president to make available accommodations for our membership to use year round. Members would need to obtain a U.S. Passport in order to access the island and the resort. When we arrive, our lodging, food and beverages would be included with our stay; our only cost would be our airfare.





Casino Royale & Retail Mall

Casino Royale is located directly across from the Resort and is included in the purchase price of the property. It features 300 Gaming devices as well as 21 Table Games comprised of Blackjack, Roulette & Crap Tables and has a live poker room. The atmosphere is quite similar to our first casino, small and intimate. The Top Level of the Casino features a high end Asian Fusion restaurant and a lounge that overlooks the street below.

During the day, locals dominate the scene and by night, the guests of the surrounding resorts line the streets in elegant attire. The property also owns the retail mall that starts from the east side of the resort and continues several blocks north, on both sides of the street.

High end restaurants, jewelry stores, lounges, karaoke bars, burger joints, and gift shops adorn the street on both sides. The property also owns several buildings that are leased to a wide variety of tenants, one being a strip club, that seems from the road, to be a hoppin' place almost anytime of the day.

The Resort, Casino & Shopping Mall all are powered by a solar farm just blocks from the resort. The solar farm provides enough energy to power the properties for up to 8 hours per day, which proved quite useful during the last hurricane 7 years ago. While the island itself struggled to return power to its residents, the resort was able to continue it's operation due to the solar farm.



Legislative Update



On the last day of our trip, we were given an update as to where the Marijuana initiative, developed by Native Nations, was in the parliamentary process by Mr. Brian Hall. Mr. Hall is the legal mind behind navigating our legislation through the parliamentary approval process. Currently there are no marijuana laws on the island, which has caught the government's attention as an additional source of revenue to supplement their tourism dollars, which is their only source of income.

Mr. Hall stated that there are two more parliamentary committee's that must approve our marijuana initiative; once approved and signed into law, we will be granted a 10 year exclusive license to develop, cultivate, sell and distribute marijuana on the island. This, in itself, is a monumental opportunity, that when this initiative becomes law on the island, it will be a game changer for our nation.



Coupled with the opportunity of purchasing the resort and the possibility of combining the two business ventures, we could see the end of depending on Federal Assistance in the near future. The opportunities for our membership from home ownership on the island to retirement, employment and entrepreneurial ventures are endless.

As with any possibility it is easy to be blinded by the sunlight dancing off the waves but the necessary questions must be asked and answered; mitigating as much risk to the membership as possible. If we can pull it off financially and it provides a good return on our investment, I'm all in.

Lastly, it may be time to introduce the Indian Taco to the Island's Cuisine. Any takers?


