Locate the family size in the far left column. Follow the line across to find the top number which most closely matches the family's estimated gross monthly income. The number directly below is would be the estimated Family co-payment which the family is responsible for paying each month.

- Co-payments are calculated on a per month basis
- Families with gross income 175% and below FPL do not have a required payment
- Families at 200% - 300% FPL through have a co-payment between .33% - 1.65%
- Co-payments remain the same, regardless of the cost of care or what type of care is selected
- This sliding fee scale is based off 2023 federal poverty level and South Dakota State Median Income of 2023.
