Locate the family size in the far left column. Follow the line across to find the top number that most closely matches the family's estimated gross monthly income (all sources, including wages, child support, etc.). The number directly below would be the estimated Family co-payment which the family is responsible for paying each month.

- Co-payments are calculated on a per-family basis
- Families with gross income 100% of FPL do not have a required payment
- Families at 138%-300% FPL have a co-payment within 1.5% - 2.5% - 3.5% - 4.5% - 5.5% 6.5% - 7%.
- Co-payments remain the same, regardless of the cost of care or what type of care is selected
- This sliding fee scale is based on the 2024 federal poverty level and South Dakota State Median Income of 2024
